<p>4. <b>College Board AP Participant Grants:</b></p> <p>The College Board offers AP Participant Grants for eligible teachers new to an AP subject to attend a College Board-endorsed AP Summer Institute (APSI), covering only the cost of tuition.</p> <p>Applications for these grants are open from March to June, or until funds are distributed, and are managed by the individual APSI host institutions.</p> <p>To apply, teachers must visit the College Board’s AP Participant Grants page and select an APSI in their application.</p>	<ol style="list-style-type: none"> <li>1. Go to the College Board AP Participant Grants page to find the application.</li> <li>2. Complete the application and select an AP Summer Institute that you wish to attend.</li> <li>3. Await notification: The College Board reviews and approves applications on a rolling basis.</li> <li>4. Registration: The College Board will share a report with the host institution, who will then provide you with a Cvent discount code to complete your registration for the APSI.</li> <li>5. Important Information</li> <li>6. Grants are not renewable or transferable.</li> <li>7. AP Participant Grants are for the current year only.</li> </ol>

# CANCELLATION AND REFUND POLICIES

❖ If the APSI cancels a session, 100% of the paid amount will be refunded.

*Courses with insufficient enrollment may be cancelled on or before June 1, 2026.*

1. Participants will be notified by email if the APSI must cancel a session.
2. Full refunds will be processed and submitted to the individual or school who paid the registration fee.
3. *The APSI will NOT be responsible for any charges related to travel or other personal expenses.*

• Registrants who cancel their registration in writing by June 1, 2026 will receive a refund of the amount paid minus a cancellation fee of \$100.00.
